Dr. Probstfeld asked the presidents to review the comments submitted in regard to FTE and increasing academic support services. This information will be used in the building capacity to serve conversations with legislators. This information will be used in the legislative budget request, in particular, additional funding to add programs that are important in the community. Dr. Katherine Johnson suggested a panel of three to five CEOs be invited to speak with the presidents about the outcome of this analysis after the November election. Dr. Ed Massey reiterated the importance of engaging community workforce leaders.
