Spring Conference

The Spring Conference will be held with the joint conference in Daytona, May 21-22.

<u>Budget</u>

Our financial status is very healthy. With the Awards of Excellence fees, we have surpassed \$17,000. Awards of Excellence are our main source of fundraising.

LeRoy Collins is a separate budget. It's an expensive event to put on, and years ago the commission paid for a consultant to coordinate the entire event. To help contain costs, we stopped using the consultant in 2009, began printing booklets in-house, and employed a few other cost savings measures. We are in the black for the current event and the last event (2011) so we are in a good spot for future Leroy Collins events.

Burst the Balloon - \$1,000 contribution was asked from AFC from each commission. Motion and second, no questions, all approved. Motion unanimously passed to contribute \$1,000 to the AFC Burst the Balloon campaign.

Spending Policies

Discussion on whether we should have a policy in the bylaws regarding the spending policy of the Awards of Excellence and the LeRoy Collins Awards or suggest some guidelines and not make them a bylaw. Part of discussion brought up the reasoning behind the elimination of a treasurers position in the board. AFC does most of the financial accounting and provides information on our accounts. The CMC board decided last year to eliminate the position and created the Communications officer position instead. Members in attendance agreed that a change in the bylaws at this time was not warranted and that we should just make some guidelines for those handling the Awards of Excellence and the LeRoy Collins Awards to keep the budget in check.
