#### 7.4 FCSAA

Dr. Chuck Hall referred to the handout entitled <u>FCSAA Report to the Council of Presidents</u> (**Attachment C.**) Mr. Jeb Blackburn reviwed the revision to Article 19, Addition of New Divisions.

<u>Action:</u> Upon a motion by Dr. Ed Meadows and a second by Dr. Gene Prough, revision to Article 19 was approved without objection.

Mr. Blackburn also reported the the coaches/institutions were surveyed to determine if there was interest in increasing the Men's Basketball Letters of Intent from 12 to 15. The majority voted not to increase the Men's Basketball LOI's therefore it is not being brought as an action item. The Baseball Coaches, CAA and the FCSAA Executive Committee recommend increasing the Baseball Letters of Intent from 18 to 24 which is the NJCAA limit with the additional 6 scholarships being limited to tuition, fees and course related books. This would be effective for the 2014-15 academic year.

<u>Action:</u> Upon a motion by Dr. Chuck Mojock and a second by Mr. Joe Pickens, the increase in letters of intent from 18 to 24 in baseball with the additional 6 scholarships being awarded for tuition, fees and course related books only was approved with six objections.

Mr. Blackburn also announced there will be ten inductees to the Hall of Fame this year.

Mr. Jacob Winge referred to the handout entitled <u>Florida College System Student Government Association (Attachment D.)</u> He reported the FCSSGA will hold their President's Assembly from November 7-8 in Jacksonville. During the meeting, the legislative platform issues will be voted on.

#### 7.5.2 **COBA**

Ms. Gina Doeble reported COBA met at the end September at the College of Central Florida. One issue that was discussed was undoing senior management designation. She added COBA will work with the lobbyists on this issue.

COBA has also formed a workgroup to look at textbook affordability.

Ms. Double reported COBA recommends that Al Little (St. Johns River State College) term be renewed and Barbara Larson (Hillsborough State College) replaces Gean Ann Edmond (Pensacola State College) on the Operations Committee effective March 1, 2014. In addition it is recommended that Peter Elliott from Polk State College serve as the member in training.

<u>Action:</u> Upon a motion by Dr. Ken Atwater and a second by Dr. Ann McGee, the recommendations to the Operations Committee effective March 1, 2014 was approved without objection.

#### ARTICULATION AGREEMENT BETWEEN

#### THE DIVISION OF FLORIDA COLLEGES

#### AND

#### JOHNSON & WALES UNIVERSITY

This Articulation Agreement is entered into this _	day of	, 2013, by and
between the Division of Florida Colleges and Johnson &	Wales University.	

**WHEREAS**, the parties desire to promote the most efficient and effective use of their resources and to offer students the broadest possible range of educational opportunities, and

**WHEREAS**, the parties desire to encourage and facilitate the establishment of specific articulation provisions between Florida's public colleges and Johnson & Wales University, and

**WHEREAS**, the intent of this agreement is to facilitate the transfer of qualified associate degree students from Florida's public colleges to Johnson & Wales University,

**NOW, THEREFORE,** the parties agree to cooperate in articulating programs in accordance with the terms set forth herein.

- I. Johnson & Wales University shall recognize the Associate in Arts degree as the transfer degree from the Florida College System. Also, specified Associate in Science and Associate in Applied Science degrees will be eligible for articulation in related baccalaureate degree programs offered at Johnson & Wales University.
- II. Johnson & Wales University shall annually provide data to the Division of Florida Colleges on the number of FCS graduates by academic term that enroll under the provisions of this agreement and graduate with the baccalaureate degree.
- III. Johnson & Wales University and the Division of Florida Colleges shall agree to the following conditions:

#### **Associate in Arts Degree Articulation**

- A. Florida College System students who transfer with an Associate in Arts degree under the terms of this Agreement shall enter with junior standing and all credit awarded by a Florida College System institution will transfer to Johnson & Wales University, which includes a minimum of 60 semester credits. However, the student must meet the specific degree course requirements of Johnson & Wales University, which may mean extending the number of credit hours to earn the baccalaureate degree, if the 60 semester hours transferred and applied do not include all of the degree prerequisites or graduation requirements that are compulsory for native students.
- B. Florida College System students who transfer under the terms of this Agreement shall be considered as having completed the general education requirements of Johnson & Wales University. However, Johnson & Wales University may specify additional courses that must be completed prior to the awarding of the baccalaureate degree. These courses may be completed at either institution.

#### **Associate in Science Degree Articulation**

C. Appropriate courses within the Associate in Science or Associate in Applied Science degree will articulate to related baccalaureate degree programs at Johnson & Wales University. Courses taken as a part of the Associate in Science or Associate in Applied Science degree to meet the general education requirements of the Florida College System institution will transfer and apply toward the Johnson & Wales University general education credit hours required for the baccalaureate degree. No additional general education credit hours can be required except to complete the total general education hours required by Johnson & Wales University. The student must meet the specific degree course requirements of Johnson & Wales University, which may mean extending the number of credit hours to earn the baccalaureate degree at Johnson & Wales University.

#### **General Articulation Provisions**

- D. Transfer students shall meet the same standards and program requirements as native students. This may include admissions requirements (i.e., standard high school diploma or high school equivalency diploma), college placement testing, and prior successful completion of all college preparatory coursework as mandated by state approved assessments and standards. Failure to demonstrate adherence to agreed-upon standards of individual student college readiness may abrogate guarantees for transfer of credit for specific students or termination of this agreement.
- E. Admission of a Florida College System student to Johnson & Wales University will depend on the number of spaces in each academic year and the continuation of the program. Program discontinuance will remove any obligation (beyond those protections afforded to native students) of Johnson & Wales University to comply with the provisions of the Articulation Agreement relative to the discontinued program.
- F. For the students accepted for transfer, Johnson & Wales University requires a grade point average (GPA) of not less than 2.0 overall or a grade of "C" or better in all courses.
- G. Credit awarded by a Florida College System institution as credit awarded by exam, such as College Level Examination Program (CLEP), International Baccalaureate (IB) Program, Advanced International Certificate of Education (AICE) Program, and Advanced Placement (AP), while acceptable to satisfy associate degree requirements, may or may not satisfy specific requirements of the baccalaureate degree. The Johnson & Wales University policy on accepting credits awarded as experiential credit and credit by exam will be applied the same as native students.
- H. Authority over all academic policies or practices not mentioned in this agreement shall remain with Johnson & Wales University.

#### **Scholarships**

I. Florida College System students who transfer under the provisions of this agreement are eligible for the following scholarships.

Students must have completed a minimum of 30 semester hours at another institution and maintained a minimum 2.75 cumulative grade point average. Students must maintain a GPA of 2.75 in order for the scholarship to be renewed. The scholarship application is the application for admission to the university.

Associate in Arts, Associate in Science and Associate in Applied Science degree holders with a qualifying GPA are guaranteed the following scholarships:

- VI. During the period of this Agreement, the Division of Florida Colleges shall:
- A. Publicize the Articulation Agreement among the faculty, staff, and students in the Florida College System via the Florida Virtual Campus website as well as other Department of Education and Division of Florida Colleges publications, correspondence, and outreach activities.
- B. Make available to faculty members, counselors, students, and other appropriate individuals within the Florida College System, the Johnson & Wales University admission requirements; preferred general education requirements; program prerequisite courses, other related requirements. This will be done via the Florida Virtual Campus website.

#### VII. Both parties agree:

- A. To cooperate on curricular and advising issues that will facilitate future student transfer.
- B. To foster communication between Johnson & Wales University, the Division, and the Florida College System. The following individuals will serve as liaison officers for matters relating to this agreement:

Both parties agree to notify the other of any changes in contact information for their respective liaison officers.

- D. To provide for periodic review of the Agreement to evaluate articulation between the Florida College System and Johnson & Wales University to include all campuses. The review should be initiated by the Division and should take place at least once every three years, following initial implementation of the Agreement.
- VIII. Applicable Law. This Agreement will be governed and construed in accordance with the laws of the State of Florida and the rules of the State Board of Education.
- IX. Modifications. Any modifications, additions, or deletions to this Agreement must be in writing and signed by both parties. The designated representatives are the Vice President of Academic Affairs (Providence campus) Johnson & Wales University and the Chancellor for the Division of Florida Colleges.
- X. Termination of the Articulation Agreement. Either party may terminate this Agreement by giving written notice to the other party. The notice shall state the effective date of termination which shall be at least one year after the date on which the notice is received by the other party. Any student enrolled in a Florida College System institution during the time this Agreement is in effect shall continue to receive the benefits of the Agreement until the effective date, one year after notification, provided all conditions contained herein are met by the student.
