## **1.0 Approval of Minutes**

### **1.1 Approval, Policy & Advocacy Meeting Minutes, October 30, 2014**

**Action:** *Upon a motion by Dr. Chuck Mojock and a second by Dr. Jonathan Gueverra the minutes of the October 30, 2014 meeting of Policy & Advocacy Committee were approved by without objection.*

## **2.0 2015 Substantive Issues**

Dr. Probstfeld referred to the handout entitled Rebuilding the Capacity to Serve Florida College 2014-15 Legislative Platform (Attachment A.) Dr. Probstfeld reported language on equity funding will be added. Dr. Jim Murdaugh suggested rewording the title “Rebuilding Capacity to Serve”. Dr. Murdaugh stated the Governor feels he has been supportive of capacity and suggested a message that ties in the phrase “Let’s Get to Work”. Dr. Probstfeld suggested removing the word “Rebuilding” from the title all together and work in the “Let’s Get to Work”. Dr. Mojock suggested adding it to the first bullet. Dr. Probstfeld suggested adding equity as the third bullet under “Capacity to Serve”. Dr. Probstfeld will make the suggested edits and resend to the presidents.

Dr. Mojock asked if the Media and Public Relations Committee would be able to share the document with Moore Communications Group for their input. Dr. Probstfeld stated the Committee could share it.

Matt Holliday reported the lobbyists are already tracking bills that have been filed that involve the Florida College System.

Dr. Chuck Mojock asked whether or not the revenue estimates have been released. Ms. Stacey Webb reported this year the surplus is as small as \$200 million. The passage of Amendment 1 will impact appropriations. Chancellor Hanna reported PECO is estimated at \$88 million total.

Dr. Carol Probstfeld adjourned the Policy and Advocacy Committee meeting at approximately 10:17 a.m. without objection.
