#### FLORIDA COLLEGE SYSTEM COUNCIL OF PRESIDENTS Minutes of Council of Presidents Business Meeting (DRAFT until approved) June 13, 2024, Florid SouthWestern State College / Zoom

#### Call To Order

President Ed Meadows called the Council of Presidents meeting to order at 9:09 a.m. E.T.

#### Roll Call and Quorum Check (alpha by college, 15 presidents required for quorum)

#### A quorum was present.

#### **Approval of Minutes**

A motion was made, seconded, and approved to accept the minutes of April 19, 2024 and May 17, 2024 as presented.

#### Chair's Report

President Meadows discussed the passage of HB 5101, which includes Florida State Colleges in the state health insurance program but noted the Governor's veto of the \$80 million associated with the implementation. The Council discussed the implications of the mixed actions and agreed that more research is needed to understand the impact to the implementation and start date for colleges. Presidents Pumariega and Meadows will serve as liaison with DMS and report findings to presidents.

President Meadows announced that President Allbritten was nominated to serve as Chair of the Council of Presidents and Presidents Lorenz and Broadie were nominated to serve as Chair and Vice Chair, respectively, of the Policy and Advocacy Committee. There were no additional nominations from the floor. **A motion was made, seconded, and approved to accept the nominations as presented.** President Meadows congratulated the presidents and passed the gavel for the remainder of the meeting to President Allbritten. A congratulatory message from Senate President Passidomo was played during the meeting.

President Allbritten thanked the Council for the selection and shared his appreciation for the leadership of President Meadows over the past year.

President Allbritten acknowledged, thanked, and presented a token of appreciation to Ms. Judy Green who recently retired as president of the FCS Foundation.

#### Policy and Advocacy Committee

President Lorenz opened the committee meeting of the Policy and Advocacy Committee. President Lorenz reported that the top priority that was agreed to by the committee was additional recurring funding, and proposed \$250 million dollars in new recurring operational funding to go through the funding formula, as well as restoration of "sum of the digits" repair and maintenance money and sustained funding for the non-program fund categories, such as the 2+2 workforce succeed, LINE and Pipeline, industry certification, dual-enrollment, scholarships, and others that sit outside of the program funds. The strategy will focus on a data-informed narrative around the value proposition we offer the State of Florida and a unified front from all FCS colleges. **A motion was made, seconded and approved to accept the proposal.** President Lorenz also mentioned convening a planning meeting in the fall for college governmental affairs representatives and presidents.

Seth McKeel and Lacey Hofmeyer provided an update on bills awaiting signatures and discussed planning for the upcoming legislative session.

#### Report of the Chancellor, Division of Florida Colleges and Division of Career and Adult Education

Chancellor Hebda thanks presidents and their trustees for their participation in the Commissioner's Summit. The Chancellor also discussed the Teacher Pipeline Summit, the Student Success Center's work on Dual Enrollment, apprenticeship programs, FCS Foundation grants, the data for the funding model, the upcoming State Board of Education meeting which will feature rules related to the specialized AA transfer degrees and various articulation agreement elements, workforce certifications, general education requirements, residency guidelines, civic literacy, nursing education, and upcoming RFPs.

Chancellor Hebda presented an update on behalf of Chancellor O'Farrell, highlighting the Industry Certification Funding List, the CTE Audit Rule, and the rule allowing technical colleges to apply for associate in science degrees.

The Chancellor expressed gratitude for the collaborative efforts of all institutions and emphasized the importance of staying updated with policy changes.

#### Florida College System Risk Management Consortium

President Allbritten entertained a motion to fill an open seat on the FCSRMC. A motion was made, seconded, and approved to appoint President Heather Bigard as the Vice Chair for the Risk Management Council and the Ops Committee.

President Jim Henningsen called the Risk Management Council meeting to order. Mr. Chauncey Fagler reviewed the Board packet provided and the two action items included for action.

A motion was made, seconded, and approved to update the Risk Management Manual with the following language related to Untimely Withdrawal: "Member Colleges who leave the P&C program without a timely notice will be charged a withdrawal fee of 50% of the previous year's allocation."

A motion was made, seconded, and approved to ratify the Employee Benefits Plan Audit as presented.

#### **Articulation Coordinating Committee**

President Broadie provided an update on the changes related to the Applied Technology Diploma (ATD) Articulation Agreements, the Statewide Career Pathways Articulation Agreements, and the Regional Career Pathways Articulation Agreements. President Broadie also shared a legislative update prepared for the Articulation Coordinating Committee.

#### Media and Public Relations Committee

President Falconetti reviewed recent activities including the campaign highlighting FCS presidents and various annual appreciation events celebrating teachers, nurses, and the military. Ms. Karen Moore updated the Council on activities over the prior year and discussed plans for the upcoming year.

#### **Council of Instructional Affairs**

Dr. Senker provided an update from the Council of Instructional Affairs (CIA) and introduced Dr. Matthew Liao-Troth of St. Petersburg College as the incoming chair.

#### **Council of Student Affairs**

Dr. Erik D'Aquino provided an update on the Council of Student Affairs (CSA) and introduced Dr. Kathy Karran-McCoy of Palm Beach State college as the incoming chair.

President Broadie thanks CSA for their focus on mental health and shared copy of related digital resources associated with the "mind, body, life" initiative developed by Santa Fe College.

#### **Council of Workforce Education**

Dr. Jodi Long provided an updated on the Council of Workforce Education (CWE) and introduced Dr. Prashanth Pilly, of Indian River State College, and Dr. Alexia Rolle, of Miami Dade College as co-chairs for the Council.

#### <u>COBA</u>

Mr. Chuck Prince provided an update on the Council of Business Affairs (COBA) and introduced Dr. Barbara Wills of Tallahassee State College as the incoming chair for the Council.

#### **Council of Resource Affairs**

Ms. Jamie Bateman provided an update on the Council of Resource Affairs (FCRD) and introduced Mr. Philip Dickey of Miami Dade College as the incoming chair for the Council.

#### Report of the Florida College System Activities Association

Ms. Kelly Warren reviewed proposed changes approved by the FCSAA Executive Committee. The following action items (with details included in the FCSAA report included in COP package) are proposed for ratification by the Council:

- 1) Proposed Language Deletion in the FCSAA Constitution and By-Laws, Article 4 Organizational Structure, Section 4.
- 2) 2024-2025 Executive Committee Roster.
- 3) 2024-2025 Proposed Budget and 2023-2024 FCSAA Operating Expenditures.
- 4) 2024-2025 Proposed Institutional Dues.

A motion was made, seconded, and approved to accept the four items as presented (with details provided in the report).

# A motion was made, seconded, and approved to appoint President Tonjua Williams as the COP representative to the FCSAA Board.

Ms. Warren highlighted various athletic successes, including Indian River who won the Division 1 Baseball National Championship; St. Johns River who won the Division 2 Softball National Championship; Florida Gateway who won the Women's Flag Football National Championship; Daytona State who won Women's Golf National Championship; and Palm Beach who won the Beach Volleyball National Championship.

Ms. Warren highlighted various academic division successes, including Chipola College for the equivalent of their National Championship, and TSC for their forensics debate teams.

#### **Report of the Association of Florida Colleges**

Mr. Matt Wetzel thanked Daytona State for hosting the recent Campus Safety and Resilience Symposium, reviewed the progress on the AFC Reimagining Initiative, and highlighted the upcoming Joint Annual Conference with AFC, COP, Trustees, and Councils, scheduled for November 5-8 in Orlando.

Mr. Tony Carvajal reviewed success over the year, highlighted 10 strategic imperatives AFC will focus on as it moves forward, and discussed the impending sale of the AFC Building owned by the Foundation.

#### **Other Business**

President Allbritten thanked Council members and Florida SouthWestern State College staff who helped with logistics for the COP annual meeting.
